the depositors' claims against the trust's agent were claims against the agency, and that the corporation therefore is not entitled to indemnification. Undoubtedly, the corporation was indebted to the bank, but by reason of the limitations on the liability of the agency the bank was not the principal in the sense in which the word principal is employed in relation to the principal and agent. But we think it also must be conceded that the corporation, in asserting that the bank is liable for

its negligence, is asserting a claim against the bank based on a contract which was the very subject of the arrangement under which the corporation assumed the obligations of the bank. The bank was the principal and had agreed to be responsible for the corporation's acts; and the corporation contracted to assume that responsibility and to pay the bank a reasonable compensation for the assumed responsibility. The corporation could not have obtained the bank's agreement to be responsible without assuming the obligation of paying a

reasonable compensation.

Consequently, in every sense and under the circumstances of the case, the corporation and the bank are principal and agent. The judgment was given against the bank for \$10,000. The bank's motion for new trial asked for a new trial as to the bank only, and that part of the judgment was not disturbed. The bank, then, was the only party affected by the judgment, and that judgment was correct, unless it is a bar to the proceedings in equity to compel the corporation to take over the invalid obligations of the bank.

The grounds upon which the district court, at the suit of the stockholder of the bank, appointed the receiver for the bank were stated to be the insolvency of the bank, its failure to pay its notes, and its failure to pay dividends, and the appointment of a receiver, under those circumstances, was a proper exercise of the court's jurisdiction.
