(CNN) It took three years for a hopeful couple to meet the person they would marry.

And even now, at the moment they tied the knot, they're still not in the clear.

After a judge in

Pennsylvania ruled last week that the lesbian couple could legally wed on September 30 in the state, the state filed an appeal in the case. In a case that has garnered broad interest and support, the state's Court of Common

---

Pleas said the group of same-sex marriage opponents had standing to pursue their appeal. The group appealed the court's ruling that overturned the Defense of Marriage Act, which defines marriage in Pennsylvania as between a man and a woman. The state's appeal stopped the Pennsylvania Superior Court from issuing a stay of execution, effectively nullifying the validity of the marriage. The state attorney general's office has said it will seek to have the US

---

Supreme Court take up the case, calling it an issue of national importance. The couples had married in Maryland and flew to Pennsylvania to make the marriage legal. They filed suit with the Pennsylvania Supreme Court in 2004, arguing that the state's lack of a statewide law on same-sex marriage violates due process and equal protection under the state constitution. The Court of Common Pleas ultimately agreed, holding that the state's marriage law

---

violates due process. "The court further declared that the marriage at issue, even if technically valid, does not entitle the Plaintiffs to the substantive right to marry," the state court wrote in its opinion. "This right is a matter governed by the Commonwealth's Constitution and Supreme Court's interpretation of the Pennsylvania Constitution." The couple, Francine Rogers and Joanne Schroeder, now live in New Jersey and have two daughters and one son.

---

They say they want to make it clear that if they were barred from marrying, they would like to have grandchildren, too. "My feelings of what it would mean to be married and my kids be exposed to what they already know -- that they have a mother and a father -- it would be heartbreaking," Rogers said. Shortly after the decision was issued, they married in New Jersey. The announcement of that decision came in a press release in April from the

---

attorney general's office.

"We are not backing down, and we will continue to pursue this case, as necessary, to ensure that all Pennsylvanians -- regardless of their sexual orientation -- are able to access the fundamental right to

What's New In?

The last time we saw Chelsea Manning, she was on the run as a whistleblower. Her morale had never been higher. At 27, she had taken

---

a principled decision and had decided to lift the veil on the reality of the illegal war, in which she had been deployed as an intelligence analyst. As the public prosecutor, she had asked the United States government to investigate this war, which had been waged on the basis of lies. She had given up a safe career in the uniform of the US Armed Forces in order to risk her life in order to make this declaration known to the American public. Since then, a few things have happened.

---

President Barack Obama has pardoned her, and many reprieved prisoners have regained the freedom that they lost. Manning still serves a 35-year sentence for espionage, but this sentence is longer than that normally expected for high-level espionage cases. Moreover, her identity has been kept secret. The treatment meted out to her was beyond the pale of respect. The Director of Public Prosecutions never even charged her. Publicly, the key question is whether

---

the prosecution and public prosecution were right in not seeing the motives of the leaker of secrets, and in treating her as a traitor – a war criminal according to the Manning verdict. In my opinion, they were wrong to do this, and the rest of us are led to wonder if it was because they believed that she had given the American government secrets she had been entrusted with, and which would harm US interests? If so, we need to remember that Manning was

---

an analyst, not a seer. Her job was to find out the facts.

What she found out, and then acted on, were lies, and the damage they caused. Indeed, she had been chosen because she had never been involved in the wars in Iraq and

Afghanistan. The war-power over which she presided was a huge secret. Since the war in Iraq had been illegitimate, she was a privileged member of a secret society of whistle-blowers. She was of a generation that considered its democracy of little

---

consequence. Her conscience dictated to her. The arguments for a full pardon, and for lenient treatment in prison, fall into two categories. First, the supposedly “genuine” anti-war movement of the 21st century needs to overcome its own prejudices and stop demonising whistleblowers, or at least recognise them as heroes who have done what they thought was the right thing to do. For a

---
